SUBJECT:

Disposition of Property

Item Description

Disposition of property per TCC policy 6Hx27:09-10.

Overview and Background

The four vehicles identified on the attachment have been utilized exclusively by the FDOT Florida Law Enforcement Liaison Program and have outlived their useful life. Extensive travel and towing have contributed to extensive wear and tear, significantly diminishing the useful life of these vehicles.

The current mileage for each of the vehicles is in excess of 100,000. In addition to standard maintenance and servicing, these vehicles have experienced a number of mechanical failures making them uneconomical and inefficient. The mechanical limitations in towing capacity leave these vehicles insufficient to execute the goals and objectives of the program.

The total value of all four vehicles when they were purchased through the FDOT grant was \$112,118.00. The current depreciated combined value is \$5,606.09.

Approval to dispose these vehicles was granted by the sub-grantor (FDOT) on March 20, 2012. Section 274.05, FS, allows a governmental unit the discretion to classify as surplus any property that is obsolete, or the continued use of which is uneconomical or inefficient, or which serves no useful function. Section 274.06, FS, allows property which a governmental unit estimates to be under \$5,000, to be disposed of in the most efficient and cost-effective means as determined by the governmental unit including disposal for value to any person, or disposal without bids to the state, or disposal to any governmental unit or to any political subdivision. Federal regulations CFR Title 49, Section 18.32 allows for the disposition of items of equipment acquired under a grant or sub-grant having a current per-unit fair market value of less than \$5,000, to be disposed of with no obligation to the awarding agency.

Past Actions by the Board

There has been no previous action by the Board on this disposition.

Funding/Financial Implications

The residual (depreciated) value of each vehicle will be used for trade-in on the purchase of replacement vehicles for the Florida Law Enforcement Liaison Program.
