Tallahassee Community College Spot Survey Approval for Gadsden

County

Item Description

This item requests District Board of Trustees approval for a spot survey requesting permission to acquire additional property in Gadsden County.

Overview and Background

The District Board of Trustees approved the current TCC Educational Plant Five Year Survey Report at the August 16, 2010 meeting. Since that time, TCC staff has identified a need to acquire additional property in Gadsden County to accommodate the needed expansion of the programs now run out of the Quincy House Special Service Center. Before additional property may be acquired, a spot survey requesting the acquisition must be approved by the Board of Trustees and forwarded to the Department of Education.

At this time, the spot survey consists only of the one-sentence request to acquire additional property, and no further COFTE projections or other backup is required. TCC staff are currently working to develop a more complete description of the desired programs in Gadsden County, and we anticipate returning to the Board of Trustees in several months with another survey request that more completely describes the anticipated programs.

Past Actions by the Board

The District Board of Trustees approved the current TCC Educational Plant Five Year Survey at the August 16, 2010 meeting.

Funding/Financial Implications

The College is not committed to expend funds to acquire additional property simply by approval of its request. Any additional action will be undertaken under the rules and direction of the Board of Trustees.
