Project Priority List (PPL)

Item Description

This item requests approval of the updated Project Priority List (PPL) for expenditure of Capital Outlay and Debt Service (CO & DS) funds received from the Department of Education.

Overview and Background

The Department of Education annually disburses CO & DS funds to Tallahassee Community College. The College is required to expend these funds in accordance with an approved plan referred to as the Project Priority List (PPL).

The projects included in the PPL must be recommended in TCC's Five Year Educational Plant Survey. The Board approved the new Educational Plant Survey for all sites on August 16, 2012, and a Spot Survey for Gadsden County sites on March 19, 2012. The PPL has been updated to reflect the approved Survey documents.

Draft copies of the updated documents are attached. The Department of Education's online system automatically assigns a separate PPL to each version of the Survey, so two documents are attached. After approval by the District Board of Trustees, the draft PPL documents will be electronically transmitted to DOE for approval.

Past Actions by the Board

The Board approved the previous version of the PPL in August 2007.

Funding/Financial Implications

The draft documents generally have brought forward the remaining projects from the previous PPL, and dropped off the completed items. While the College is projected to receive less than \$200,000 per year from CO & DS over the next several years, a larger list of projects is recommended to include funds available from previous allocations and to allow flexibility for use of the funds. In addition, if the College elects to participate in the State Board of Education Capital Outlay Bond program, the projects funded by the Bond proceeds must be included on the approved PPL.

The approved PPL allows the expenditure of annual CO & DS funds on key projects that support the educational mission of the College.
