SUBJECT: Amendment to 2013-14 Dual Enrollment Articulation Agreement with Gadsden County School District

### Item Description

This item requests that the Board approve the amendment to the 2013-14 Gadsden County School District Dual Enrollment Articulation Agreement.

## **Overview and Background**

The 2013-14 Gadsden County School District Dual Enrollment Articulation Agreement was previously approved in September. The proposed amendment is to include an additional career pathway. The additional pathway will allow eligible students who complete the secondary courses Criminal Justice I, II, and III to receive 9 college credits towards TCC's Associate's Degree in Criminal Justice Technology. The additional career pathway allows the current students who have completed the Gadsden Law and Leadership High School Academy to earn college credit at TCC.

## Past Actions by the Board

Annually, the Board reviews the dual enrollment articulation agreements for approval.

#### **Student Qualifications**

Students must meet all TCC admission requirements and present evidence of the following:

- 1. Successful completion of the Criminal Justice secondary technical program of study with a grade of 2.0 (on a 4.00 scale) or better.
- 2. Completion of Tallahassee Community College placement testing requirements.
- 3. Graduation from secondary school no more than 18 months prior to enrollment at Tallahassee Community College.
- 4. Enrollment and completion of 9 credit hours in an Associate of Science in Criminal Justice Technology program appropriate to the credit to be awarded for the specified exemption exam or industry certification.

**IN WITNESS WHEREOF,** the School Board of Gadsden County, Florida and The District Board of Trustees, Tallahassee Community College, Florida have adopted this agreement and caused it to be executed by their respective chairs and chief executive officers, in accordance with Section 1007.271, F.S., Dual Enrollment Articulation Agreements.
