SUBJECT: Amendment #1-Educational Plant Survey and Resolution of the Board of

Trustees to Dispose of Real Property

# Item Description:

This item requests Board approval to amend the Educational Plant Survey and the necessary steps to dispose of three buildings on campus.

#### Overview:

The College has concluded that Buildings #13, #14, and #29 in the College Inventory are unnecessary and unsatisfactory for either educational or ancillary uses. Neither building meets the current building codes for use by the College. Buildings #13 and #14 were formerly used by the Respiratory Therapy program. Most recently these buildings were used to store College documents. A much more suitable location has been found for storage in the northwest annex building the College purchased from the Leon County School Board.

Building #29 was formerly the concession stand for the baseball team. A new stand was constructed and this building became a storage shed for grounds supplies. This building also does not meet the current building codes for use by the College. In an effort to improve the appearance of this area, this building, considered an 'eye-sore', should be disposed of and replaced with additional parking.

## Salient Facts:

Section 1013.28, Florida Statutes, gives the Board of Trustees authority to dispose of real property that the Board deems unnecessary and unsatisfactory by amending the current Educational Plant Survey. In addition, the Board of Trustees may dispose of any land or real property to which it holds title by resolution of the Board of Trustees.

## Past Actions:

This item was submitted for action at the March Board of Trustees meeting. The Board asked that pictures and costs for disposal be gathered and presented for their action.

## Future Actions:

No further activity on the part of the Board is necessary.

# Funding/Financial Matters:

For Buildings #13 and #14, there is no cost associated with their disposal. The cost to dispose of Building #29 includes the following: (1) electrical work - \$2,860; (2) asbestos abatement - \$3,200; and (3) demolition - \$17,500, totaling \$23,560. These funds are available in the 2008-09 PECO Repair and Renovation Budget.
