#### Overview and Background

On a monthly basis, the Board's attorney submits an invoice for services provided.

## Past Actions by the Board

The Board of Trustees approved the contract at the October 18, 2010 Board meeting and shall be effective through October 31, 2011. The contract may be renewed on an annual basis with four (4) consecutive one (1) year renewals for a total contract period of five (5) years. The Board approved year five (5) of the contract at the October 20, 2014 Board meeting which shall be effective until October 31, 2015. The Board shall be billed on an annual flat fee of \$175,000 for services of the firm as approved by the Board at the October 21, 2013 Board meeting.

# Funding/Financial Implications

Funding is budgeted in Fund 1, the Current Unrestricted Fund. The total current amount due is \$15,043.16. This amount includes the monthly contracted amount of \$14,583.33 for legal services, plus the reimbursement of \$459.83 in travel costs for attendance at the FL College System Risk Management Consortium (FCSRMC) 2015 Risk Summit.
