SUBJECT: Academic Program and Course Changes

Item Description

This item presents proposed changes in curriculum for 2017-2018.

Overview and Background

The Academic Planning Committee Curriculum members review and make recommendations for Board approval for new programs and courses. Due to changes by the State Board of Education as well as the revision of programs to meet workforce demands, there are several program changes that are being proposed.

Two of the Law Enforcement Crossover programs are proposing changes in order to meet the demands of changes authorized by the Florida Department of Law Enforcement as well as the State Board of Education. The changes include a reduction in clock hours due to course content being revised and combined into other courses.

Past Actions by the Board

The Board approves the curriculum changes each year. The changes are for 2017-2018.
