The TCC Data Dashboard represents information provided by employees and students who *self-reported* their status to the College. The data also reflects *confirmed* cases of individuals who arranged their testing through the College's Human Resources Department. Information on this dashboard is subject to change based on the delayed reporting of positive test results. The dashboard, which is updated every Tuesday prior to 2 p.m., provides data from the previous four weeks.

Student data may contain information regarding individuals who are taking remote courses and are not residing in the local area.

As positive COVID-19 cases are reported, the College is taking appropriate action to prevent the spread of the virus by conducting internal contact tracing and sanitizing exposed areas. Additionally, the College has partnered with Tallahassee Memorial Hospital to provide rapid testing for employees and students. Employees and students exposed are required to self-isolate as recommended by the Centers for Disease Control.

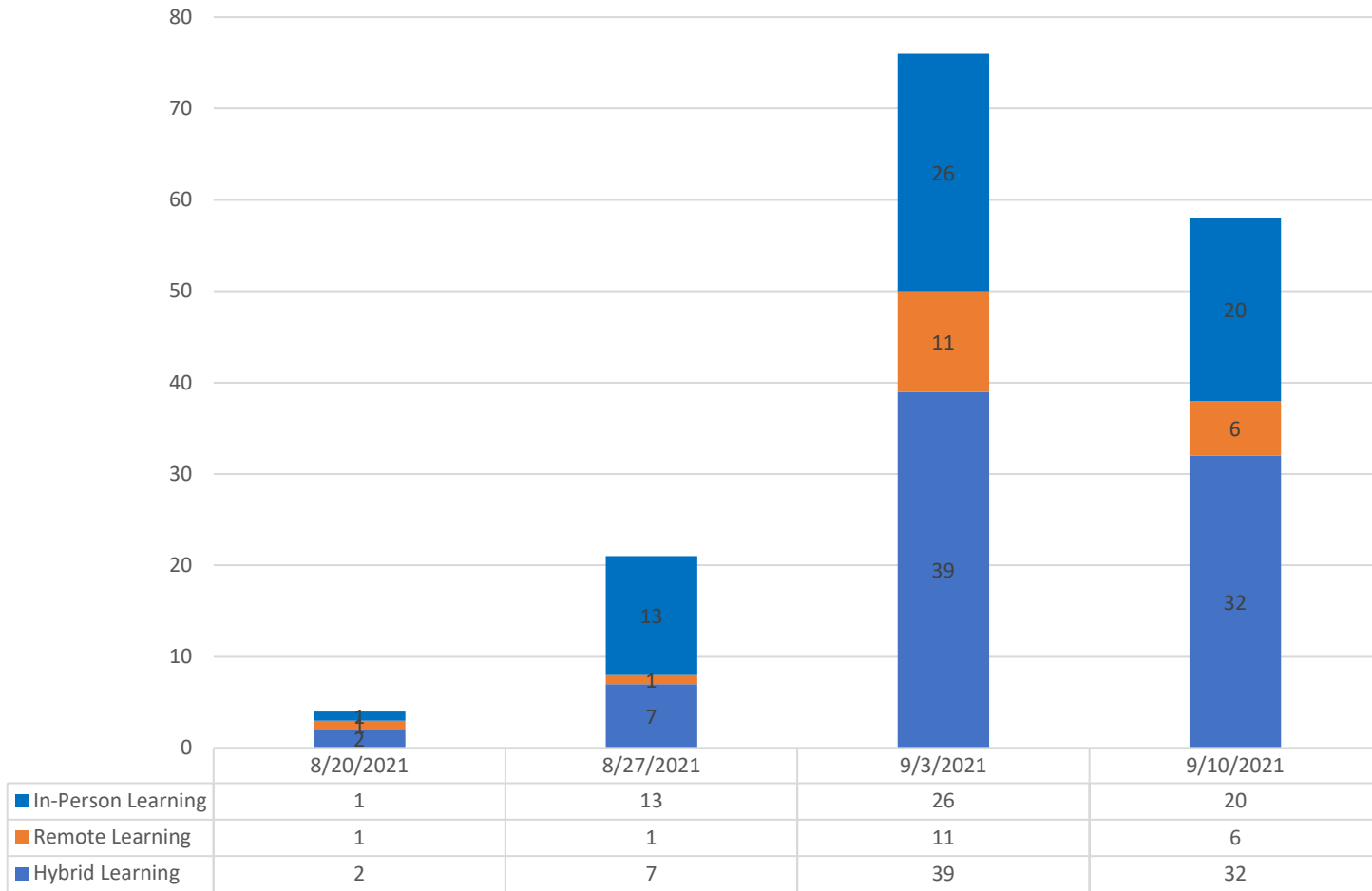
