SELECTION/ACCEPTANCE INFORMATION

After the admission requirements/tests have been evaluated, you will be notified by e-mail of your acceptance. Only applicants who submit a completed application with supporting documentation and take the course readiness testing will be considered. Applicants will be selected by their score on the EMT readiness exam and a point system. Points are awarded for complete application, completed pre-requisites, work experience and service to the community, etc.

GENERAL REQUIREMENTS FOR ADMISSION TO EMT PROGRAM

1. The applicant must be at least 18 years of age.
2. The applicant must have a high school diploma or equivalent based on the General Education Development (GED) tests.
3. The applicant must apply for admission to TCC through the Office of Enrollment Services and complete all admission requirements. International students have additional forms and documents to submit as indicated in the current TCC catalog.
4. Applicant must be college-ready in English and Reading, which means the applicant does not need developmental education courses in English and reading. The applicant must be eligible for at least Level 2 developmental math. This requirement may be satisfied by one or more of the following options: the Florida Statute on Developmental Education exemption, adequate placement scores from the Florida Postsecondary Education Readiness Test (PERT) or other college placement scores accepted by TCC, completion of developmental education courses, or completion of at least [ENC1101 College Composition](#) and Level 1 developmental math or one general education math.
5. Applicant must have also completed one of the following:
 - Approved college-level first aid course ([HSC2400](#))
 - Approved first responder course ([EMS1059C](#))
6. The applicant must be **currently certified in American Heart Association (AHA) BLS for Health Care Providers or American Red Cross (ARC) CPR for the Professional Rescuer.**
7. The applicant must submit an EMT admission application online, by the published admission deadline. Only completed applications with supporting documents turned in prior to the EMT readiness exam will be considered.
8. The applicant **must report for testing on the date given in the “Important Dates” document.**

During testing the applicant will be expected to:

- a. Demonstrate ability to lift 125 pounds.
 - b. Complete a course-readiness test based on information from the prerequisite course. A minimum score of 70 must be achieved to be considered for acceptance into the program. Bring a number 2 pencil.
9. Attend additional required intake and orientation meetings as outlined later in the application packet.
